Trump imposes 26% tariff on India

Washington: US President Donald Trump on Wednesday announced a 26 per cent tariff on Indian products and services as part of wider policy to impose sweeping 10 per cent tariffs on all countries to boost manufacturing in his country. The aggressive rhetoric came as Trump showed a willingness to dismantle a global economic system that the United States helped to build after World War II. Trump held up a chart while speaking, showing the United States would charge a 34% tax on imports from China, a 26 per cent from India, a 20% tax on imports from the European Union, 25% on South Korea, 24% on Japan and 32% on Taiwan. Cambodia will attract the highest US tariff at 49 per cent, followed by Vietnam at 46 per cent and Sri Lanka at 44 per cent — only three countries in 40-50 per cent bracket. Bangladesh will have to pay 37 per cent tariff, Thailand 36 per cent, China 34 per cent, Indonesia 32 per cent, Taiwan 32 per cent, Switzerland 31 per cent, and South Africa 30 per cent. In 20-29 per cent bracket, Pakistan will attract the highest tariff at 29 per cent, followed by India 26 per cent, South Korea 25 per cent, Japan and Malaysia 24 per cent and European Union 20 per cent. Israel and the Philippines will attract 17 per cent tariff, while the United Kingdom, Australia, Chile, Turkey, Colombia, Brazil, Singapore will attract 10 per cent tariff.

LS passes Waqf Bill After 12-hour debate

New Delhi: After an intense discussion stretched over 12 hours, the Lok Sabha on Thursday passed the contentious Waqf (Amendment) Bill 2025. The House also passed The Mussalman Waqf (Repeal) Bill 2024. Both the bills will now go to the Rajya Sabha for debate and passage and are likely to be tabled on Thursday. Terming it a historic day which will go a long way in restructuring Waqf Board functioning and protecting the lands of the people, Union minority affairs minister Kiren Rijiju said the law deals with the management of Waqf properties and does not interfere in the religion of Muslims. Caught in a quagmire, the NDA allies like the TDP and the JD(U), which have a substantial Muslim population in the states that they govern, while justifying the Waqf bill, tried to explain what all welfare work their parties and leaders have done for the minorities. Defending the bill amid the Opposition's attack, Union home minister Amit Shah, while making an intervention, made it clear that whether pe



ople like it or not, a law that is passed by the Parliament has to be accepted by all. Who are you trying to threaten? This is the law passed by Parliament and it is binding for all. Everyone has to accept it," said Mr Shah while responding to a statement by an MP who said the minorities will not accept this law. The discussion that stretched over 12 hours saw intense debate and fiery speeches from members of both the Treasury and the Opposition benches, sprinkled with wit and humour at times. The banter between Mr Shah and SP chief Akhilesh Yadav during the Waqf bill debate is a case in point.

BC Maha Dharna At Jantar Mantar Revanth warns of BC backlash



Chief Minister A Revanth Reddy pledged to organise a massive gathering of 10 lakh people to honor Prime Minister Narendra Modi if the Central government approves an increase in Backward Classes (BC) reservations in line with the resolution passed in the Telangana Assembly and subsequently approved in Parliament. Speaking at a dharna, organised by the BC Welfare Association National Committee at Jantar Mantar in Delhi on Wednesday, Revanth Reddy demanded the Union government to implement 42% reservations for the BCs. He urged the Prime Minister to heed the voices of Telangana's people and demonstrate empathy toward the Backward Classes. Leader of the Opposition Rahul Gandhi also participated in the meeting. Revanth Reddy also questioned the absence of BJP leaders from Telangana at the protest, despite the participation of 15 to 16 political parties that extended their



support. "Union Minister Bandi Sanjay proclaims that he is ready to sacrifice his life for the BCs. We do not need his life. We need just his support for the cause of BC reservations. He should live for 100 years,

but he must stand with us in this struggle," Revanth Reddy said. He pointed out that it is ultimately the Prime Minister's decision regarding the potential increase in reservations nationwide.

CM Under Fire from Supreme Court



Telangana Chief Minister A. Revanth Reddy was at the receiving end yet again. The Supreme Court faulted Telangana CM A. Revanth Reddy for his alleged statement in Assembly that there would be no bypolls in the State even if the opposition BRS members switched sides to the ruling Congress. The two-member Bench said that if the CM had made this statement on the floor of the House, he is making mockery of the 10th Schedule (antidefection law). It may be recalled that

Revanth Reddy apologised for his remarks on granting of bail to the BRS leader K. Kavitha in the Delhi liquor policy case. At that time too, the Supreme Court reprimanded the CM for his comments about a 'deal between the BJP and BRS for securing bail for Kavitha. On Wednesday, the apex court was hearing to petitions seeking disqualification of Telangana MLAs Venkata Rao Tellam, Kadiyam Srihari and Danam Nagender, who switched to the Congress, after being elected as an MLA on a BRS ticket. In November 2024, the Telangana High Court directed the Telangana Assembly Speaker to decide on the disqualification petitions in a reasonable time.

Centre Approves Rs.14,000 Cr Loan for TG from Apr-Jun

Hyderabad: The Centre has granted permission to the Telangana government to raise Rs.14,000 crore through open market borrowings in the first quarter (April-June) of the new financial year 2025-26. However, this is Rs.2,000 crore less than the Rs.16,000 crore approved for the same period in the previous fiscal year 2024-25. The Reserve Bank of India (RBI) will conduct auctions of state government bonds to facilitate the borrowings. As per the approved schedule, Telangana will raise Rs.4,000 crore in April, Rs.5,000 crore in May, and Rs.5,000 crore in June. The borrowing schedule includes Rs.2,000 crore on April 15, Rs.2,000 crore on April 29, Rs.2,000 crore on May 6, Rs.2,000 crore on May 20, Rs.1,000 crore on May 27, Rs.2,000 crore on June 3, Rs.2,000 crore on June 17 and Rs.1,000 crore on June 24. In its 2025-26 state budget presented in the Legislative Assembly on March 19, the state government proposed to raise Rs.64,539 crore through open market borrowings.

UoH protests turn violent

Hyderabad: The protest by students ns flared when students attempted and professors at the University of Hyderabad (UoH) turned violent on Wednesday as police resorted to lathicharge to disperse demonstrators opposing the Telangana government's plan to develop 400 acres of land in Kancha Gachibowli. At least 20 students are said to have been injured in the scuffle, with some requiring brief medical attention. The protest, orga nised by the UoH Students' Union and supported by faculty members, began with a peaceful march from Ambedkar Auditorium to the unive rsity's East Campus. However, tensio

to breach police barricades to inspe ct the land, which they claim inclu des parts of university departments. Eyewitness videos circulating on so cial media show police using batons against students, including female protesters. "We were just marching towards the site when suddenly police started hitting us. At least 20-30 students were injured, and two are in critical condition," said a student protester. A police official, ho wever, denied allegations of excessi ve force, stating, "We only preven ted them from taking out the rally."



Hyderabad: Those registering their unapproved layouts under the land regularisation scheme (LRS) 2020 module can avail of 25 percent regularisation charges till April 30. The state government had earlier set March 31 as the deadline for availing the rebate on the registration of unapproved layouts under the LRS 2020 module. Acting on the recommendation of the directorate of town and country planning (DTCP), the state government decided to extend the deadline on Wednesday, April 2. The principal secretary of municipal administration and urban development M Dana Kishore has directed the concerned departments to enforce the order with immediate effect.



Attention Defines Quality of Our Life



VOICE OF WORDS **Bandi Sanjay Urges Centre to Spruce** up Sports Facilities in Karimnagar

Karimnagar: In a bid to enhance sports infrastructure under the Khelo India initiative, Union minister of state for home affairs Bandi Sanjay Kumar urged Union minister for labour, employment, and sports, Mansukh Mandaviya to allocate special funds for the development of sports facilities at Dr B.R. Ambedkar Stadium in Karimnagar. The request was made in a representation submitted during a meeting in New Delhi. Former Karimnagar mayor Yadagiri Sunil Rao and Satavahana University vice chancellor Professor Umesh Kumar accompanied Bandi Sanjay. Bandi Sanjay highlighted the importance of Karimnagar in the fields of education and sports, noting that the district has earned special recognition for its achievements. "Karimnagar, one of the largest cities in Telangana, has earned a distinguished name in education and sports. It is home to Satavahana University which offers engineering and medical courses along with other educational institutions. Additionally, Karimnagar has gained prominence in sports, with Arjuna awardee Madasu Srinivasa Rao hailing from this region. Given these facts, it is crucial that the government provide appropriate



funding for the development of Dr B.R. Ambedkar Stadium in Karimnagar through Khelo India or other relevant schemes," said Bandi Sanjay. Sunil Rao and the delegation also presented details about the current state of the Ambedkar Stadium, which has faced increasing demands due to the rising number of athletes. In 1986, 22.20 acres of land were allocated for the multi-purpose sports stadium. Between 1998 and 2000 several developments including levelling, gallery construction and the creation of an 8-lane, 400-meter athletics track, were carried out with the support of MP funds, Singareni Collieries, NTPC, and other private organisations. However, with the increasing number of athletes, the existing dirt track has led to numerous injuries," they said. To address these challenges, the representation sought replacement of the dirt track with an 8-lane synthetic athletics track and installation of floodlights to allow athletes to train at night. Additionally, they recommended modifications to the current open galleries (10) to provide better protection for athletes and spectators during events. Bandi Sanjay emphasised that with the proposed developments Karimnagar's athletes will have increased opportunities to compete at national and international levels bringing pride and recognition to the country.

Harish Slams CM Revanth for Rythu Bharosa Implementation Failure

Hyderabad: BRS leader and former minister T. Harish Rao claimed said Chief Minister A. Revanth Reddy had notched yet another "failure" by failing to keep the promise to implement the Rythu Bharosa scheme from April 1 as promised. In a statement, Harish Rao accused the Chief Minister of repeatedly deceiving farmers. "Revanth Reddy made a public assurance that Rythu Bharosa funds will be deposited into farmers' accounts by March 31, a promise he reiterated during the Budget Session of the Assembly. However, the funds have not been disbursed leaving farmers disappointed," Harish Rao

Fine rice distribution unique scheme in country: Ponnam



KARIMNAGAR, The 'fine rice distribution' scheme, a unique program in the country, will ensure that every poor family in the state receive enough rice for its sustenance, transport and backward class welfare minister Ponnam Prabhakar said. Accompanied by Manakondur MLA Kavvampalli Satyanarayana, the minister inaugurated the scheme as part of the government's initiative to support low-income families, in the Housing Board Colony of Karimnagar district on Tuesday. Complimenting residents for the turnout, the

minister emphasised that the government's public welfare policies have been designed to benefit every citizen, especially the underprivileged. He highlighted the significance of the program that will distribute approximately 1.91 lakh MT of Sanna rice to 291,000 ration cardholders across 17,263 shops. "This initiative is being launched today across Telangana, and it is a great step toward improving the livelihood of our citizens," he added. The scheme was launched by Chief Minister A. Revanth Reddy in Nalgonda district on

occasion of the Ugadi.He took the opportunity to talk about other welfare initiatives of the government like free electricity to households, free RTC bus services for women and creation of 60,000 jobs. He said farmers receive Rs 500 as bonus for Sanna rice while women's groups are provided with interest-free loans. The minister assured public that the government is working on covering more people under Indiramma houses and issuing new ration cards. "We are committed to expanding opportunities for all, including SC, ST, BC, and minority communities, through schemes offering financial support ranging from Rs 50,000 to Rs 4 lakh," he said, adding the government would fulfill all its promises and expand employment through these programs.

seethakka asks police to take stern action against involved in two rape cases



Hyderabad: Panchayat Raj and Rural Development Minister Seethakka on Tuesday asked the police department to take stringent action against those who were involved in two rape cases that took place in Nagarkurnool district and Pahardisherif. In a statement, she said that she spoke to police officers and women welfare department officials concerned and enquired about the incidents at Urukondapeta in Nagarkurnool district and Pahadisherif. The Minister spoke to the Women Safety Wing Director-General Shikha Goel, Hyderabad and Rachakonda Police Commissioners, CV Anand and G Sudheer Kumar, respectively. She spoke to the women and child welfare department director A Kanthi Wesley over telephone. Stating that officials concerned provided necessary assistance to the victims, the Minister ordered them to ensure that the accused were punished severely as per law. "We responded immediately after the incidents came to light and the police already arrested all the accused within hours after the incident. We are taking care of the victims at the Sakhi center," the Minister said. "We believe that drugs were also a factor in the sexual assault incident. Our government is seriously working to curb drugs.




Telangana govt didn't take an inch of UoH's land, assert ministers



Hyderabad: Deputy Chief Minister Mallu Bhatti Vikramarka, revenue minister Ponguleti Srinivas Reddy, and IT minister D. Sridhar Babu vehemently defended the government's decision on the 400-acre land in Survey No 25 at Kancha Gachibowli, and claimed that the government had not taken any land belonging to the University of Hyderabad (UoH). In a joint press conference held at Secretariat on Tuesday, Bhatti said that the 400 acres, which had been in the possession of a private firm for more than two decades, were reclaimed after a ruling by the Supreme Court. He asserted that the land was always government property and had been brought back under public ownership. The Deputy Chief Minister condemned the BRS and BJP for spreading misinformation for political gains, specifically targeting UoH students. He said that such political tactics are detrimental to the state's development. "Under the leadership of Chief Minister A. Revanth Reddy, our government has reclaimed the land from private hands and restored it for the benefit of the people of Telangana," Bhatti stated. "This land was left vulnerable under the

previous BRS government for 10 years and is now being secured for the public. Srinivas Reddy said that the Congress, during the tenure of Indira Gandhi, had established the University of Hyderabad and allocated land to it. "The university never had legal ownership rights over land in Gachibowli, although it was set up in 1974," he explained. "The Congress government has now taken steps to grant land ownership rights to UoH, fulfilling our commitment to its development." Sudhakar Reddy criticised the former BRS government for neglecting the land's reclamation. "If the previous government had acted earlier, this 400-acre plot would not have remained in private hands," he said. IT minister Sridhar Babu said false information regarding environmental concerns were being circulated on social media platforms, specifically allegations that development of Kancha Gachibowli lands would harm natural rock formations and water bodies.



Hyderabad: A government school principal in Telangana's Vikarabad district was caught on camera indiscriminately beating female students for allegedly sneaking out of the school. A video of the incident has gone viral on social media platforms. The incident was reported from the Kottagudem Social Welfare Girls Residential School and College. The principal has been identified as Sayilatha.



Hyderabad: The protests at the University of Hyderabad (HCU) entered their fourth consecutive day, with students demanding the immediate cancellation of the proposed land auction. The ongoing agitation has drawn significant attention, prompting the police department to take decisive action. In response to the growing unrest, the Hyderabad Range Inspector General (IG) Satyanarayana has been directed to visit the university and assess the situation firsthand. Meanwhile, a large number of police personnel have been deployed near the HCU campus to maintain law and order. Students and activists have strongly opposed the land auction, arguing that it would compromise the university's integrity and affect future generations. The protestors have vowed to continue their agitation until their demands are met.

Cabinet berths for Hyd, RR dists urged

Hyderabad:Senior Congress leader Kunduru Jana Reddy has urged AICC president Mallikarjun Kharge and party general secretary K.C. Venugopal to allocate a ministerial position to the combined Rangareddy and Hyderabad districts. His appeal came amid reports that the expansion of Chief Minister A. Revanth Reddy's Cabinet was expected soon. Jana Reddy, advocating on behalf of MLAs from the two districts, emph asised that inducting a minister from the region would bolster the party's influence. He recalled that during undivided Andhra Pradesh, Ranga reddy district had five to six ministers, whereas the present Congress government has none from the region. He urged Kharge and Venugopal to ensure at least one representative from each district is included in the Cabinet expansion. Meanwhile, Congress MLAs from undivided Rangareddy district intensified their demand for Cabinet representation. On Tuesday, they wrote to Kharge and AICC leaders Sonia Gandhi and Rahul Gandhi, requesting the inclu-

sion of a representative from Rangareddy. Speaker Gaddam Prasad Kumar, who represents Vikarabad, was among the signatories. A delegation of MLAs, including T. Rammohan Reddy (Parigi), Malreddy Rangareddy (Ibrahimpatnam) and B. Manohar Reddy (Tandur), met Kharge in Delhi on Tuesday and formally submitted their request. In their letter, they highlighted the significance of undivided Hyderabad and Ranga Reddy, which together account for 42 per cent of Telangana's population. They underscored the region's strategic role as a bridge between urban and rural areas. The MLAs also noted that the previous BRS government appointed six ministers from these districts, representing Reddy, BC and Minority communities. In contrast, the current Congress government has no ministers from the area. "As we approach the GHMC and local body elections, we firmly believe that ministerial representation from these two districts will enhance the party's prospects and improve our electoral performance," the MLAs stated in their letter.

Hyderabad: TPCC President Mahesh Kumar Goud stated that the state government is not seizing the lands of Hyderabad Central University (HCU). He clarified that government lands were allocated in exchange for HCU lands some time ago, making them government property since then. Speaking at a media conference held at Gandhi Bhavan, Goud assured that any actions, including

the recent clearing of the forest area, are being taken only after legal proceedings have concluded, ensuring compliance with court orders. The state government, through the Telangana Industrial Infrastructure Corporation (TGIIC), aims to use the land for economic growth, arguing that it is not forest land but government property, as confirmed by revenue rec ords and court decisions. However, this move has sparked protests from students who argue that the area, part of the Kancha Gachibowli region, hosting diverse flora and fauna.

Hyderabad: Tension prevailed when police tried to prevent the CPI(M) leaders who had called for a protest in front of the University of Hyderabad (UoH) in support of the university community fighting against the auction of 400 acres of land. The police detained the CPI(M) leaders from entering the UoH campus to express their support to the students who are on an indefinite strike from Tuesday. The CPI(M) leaders alleged that the police brutally dragged and lathi-charged them who had called for a dharna in front of the HCU against the police's iron grip on students and demanding the release of the students in police remand and the withdrawal of the land auction. Not only are the voices of those questioning suppressed, but those who supported the questioners are also being attacked, they said. The Left leaders said that Chief Minister A Revanth Reddy has "really imposed an undeclared emergency in the state of Telangana in the name of Indiramma Rajyam and is suppressing all those who protest."They pointed out that the state government, which is struggling with the announcement made by the HCU Registrar on Monday that the survey was not conducted, is trying to suppress protests from all sides. 2500 kg narcotics seized by Indian Navy's mission-deployed warship in Indian Ocean

NEW DELHI: The Indian Navy's mission deployed warship has succeeded in seizing a large consignment of narcotics in the Western Indian Ocean region. The Navy on Wednesday said, "Indian Naval Ship (INS) Tarkash, a frontline frigate of the Indian Navy operating under the Western Naval Command, has successfully intercepted and seized over 2500 kg of narcotics in the Western Indian Ocean. On March 31, 2025, while on patrol, INS Tarkash received multiple inputs from Indian Navy P8I aircraft regarding suspicious vessels operating in the area. These vessels were believed to be involved in illicit activities, including narcotics trafficking. The P8is are Long Range Maritime Reconnaissance Anti-Submarine Warfare aircraft. In response, the ship altered its course to intercept the suspicious vessels. "After systematically interrogating all suspicious vessels in the vicinity, INS Tarkash intercepted and boarded a suspect dhow, owing to the coordinated efforts with the P8I and the Maritime Operations Centre in Mumbai." Said the Navy. A specialist boarding team, along with Marine Commandos, boarded the suspect vessel and conducted a thorough search,

leading to the discovery of various sealed packets. Further search and interrogation revealed over 2,500 kgs of narcotic substances (including 2386 kgs of hashish and 121 kgs of heroin) stored in different cargo holds and compartments onboard the vessel. The suspicious dhow was subsequently brought under the control of INS Tarkash, and the crew underwent comprehensive questioning regarding their modus operandi and the presence of other similar vessels in the area. Additionally, the

ship launched its integral helicopter to monitor the activities of the suspicious vessel and identify other vessels likely operating in the area. This seizure underscores the effectiveness and professionalism of the Indian Navy in deterring and disrupting illicit activities, including narcotics trafficking at sea. The Indian Navy's participation in multinational exercises aims to promote security, stability, and prosperity across international waters in the Indian Ocean Region (IOR). This operation underscores the Indian Navy's unwavering commitment to combating maritime crime and bolstering regional security. Deployed in the

Western Indian Ocean since January 2025 for Maritime Security Operations, INS Tarkash is actively supporting Combined Task Force (CTF) 150, which is part of the Combined Maritime Forces (CMF) and is based in Bahrain. The ship is participating in the multi-national forces joint focus operation, Anzac Tiger. Combined Task Force (CTF) 150 is one of five task forces operated by Combined Maritime Forces (CMF). NEW DELHI: Senior Congress leader P Chidambaram has said Finance Minister Nirmala Sitharaman gave a "tortuous" explanation to his question on capital expenditure, asserting that the numbers "conclusively" proved that there was a "cut" in capex during 2024-25. FM could have listed the reasons and it is for the people to decide whether the reasons are acceptable or not. "Instead, she has questioned the very comparison of BE and RE. I am astonished that the Hon'ble FM should say that comparison of BE and RE is 'flawed'. If BE and RE are not comparable, why list the two numbers side-by-side on the same page in the Budget documents," Chidambaram asked. He also asked why does the finance min-

UK to Increase Visa Fees by Up to 15% from April 1

Hyderabad: Following the steps of Australia and the United States, the United Kingdom has increased its visa fee by 10 to 15 per cent, depending on the category, effective from April 1. Additionally, the UK has introduced a £16 (Rs.1,765) fee for its electronic travel authorisation (ETA) system for visa-exempt travellers. As per the revised UK visa fees, a six-month standard visitor visa, which used to cost £115 (around Rs.10,600) will now cost £127 (around Rs.11,700). A twoyear visa, which cost £432 (around Rs.39,900), is now at £475 (around Rs.43,800). A regular student visa, which used to cost £490 (around Rs.45,200) will now cost £524 (around Rs.48,400). The short-term study visa, which is valid between 6-11 months is now £214 (Rs.19,700) against £200 (around Rs.18,400) earlier. A skilled worker visa, which grants visa under the 'Sponsor a Worker' scheme operated by the secretary of state, will now cost £769 (around Rs.71,000) for under three years and £1,160 (around Rs.1.07 lakh) above three years.

"In order to show the world that the government has 'improved' upon the original estimate of the fiscal deficit," he said. "The same logic applies to all estimates. As far as capital expenditure in 2024-25 is concerned, the numbers conclusively prove that there was a reduction (cut) in 2024-25," Chidambaram said in the statement. Earlier, Sitharaman said the capital expenditure has not been reduced but has gone up to Rs 11.21 lakh crore for the 2025-26 fiscal, and claims of cuts are misleading and based on flawed comparisons. Replying during the Question Hour in the Rajya Sabha, Sitharaman said the capital expenditure was Rs 11.11 lakh crore in 2024-25. "Actually, (in) the budget this year. It has gone up to Rs 11.21 lakh crore. So, the capital expenditure has not been cut at all," she said. "So, cutting down the capital expenditure is not the case with us," she added. Sitharaman was responding to a question by Chidambaram. Later, responding to a social media post of Chidambaram, Sitharaman said his "claims of a cut in capital expenditure are misleading and based on flawed comparisons". Chid ambaram's selective arithmetic and flawed comparisons between BE and RE of the same year may serve political rhetoric but do little for informed public discourse, she said in a post on X.

Two women Naxalites killed in encounter in Madhya Pradesh's Mandla district

BHOPAL: In an early morning anti-Maoist operation by the Madhya Pradesh police, two armed and wanted women Maoist cadres were gunned down by the state police in the jungles of Mandla district on Wednesday. Confirming the operation, special DG (anti-naxal) of MP Police, Pankaj Srivastava, told TNIE that each of the slain Maoist women who hailed from Chhattisgarh carried Rs 14 lakh bounty, meaning a collective Rs 28 lakh bounty. The women Maoists duo identified as Mamta and Pramila, hailed from Chhattisgarh and were part of the left-wing extremists (LWEs) Kanha-Bhoramdev division, which is active in Balaghat, Mandla and Kawardha districts of MP and Chhattisgarh. The incident happened in the dense forests under the Bichiya police station area of east-central MP's Mandla district at around 8 am. Arms, ammunition and a wireless set have been seized from the spot. This is the second major success for the special Hawk Force engaged in anti-Maoist operations in Maoist-affected Balaghat, Mandla and Dindori districts of MP within 42 days. Earlier, on February 19, four women Maoist cadres (the maximum in a single anti-Maoist operation so far in MP) were gunned down in an alleged encounter in the Supkhar forest area of Balaghat district. The two women Maoists killed on Wednesday morning were part of the Kanha-Bhoramdev division of the Maharashtra-Madhya Pradesh-Chhattisgarh zonal wing of the outlaws, which is active in the bordering districts of the three states. Currently, there are around 10-15 armed cadres forming the KB division, which has been active in parts of the Kanha National Park (KNP) of MP and the Bhoramdev Wildlife Sanctuary in Kawardha (Chhattisgarh) since 2019.


Centre tables contentious Waqf (Amendment) Bill in Lok Sabha, says legislation 'not about religion'




NEW DELHI: Union Minority Affairs Minister Kiren Rijiju on Wednesday tabled the Waqf (Amendment) Bill, 2025, as proposed by a Joint Parliamentary Committee, in the Lok Sabha for consideration and passage. The bill seeks to improve the administration of Waqf properties, introduce technology-driven management, address complexities and ensure transparency. Introducing the bill, Rijiju said the consultation process of the Joint Parliamentary Committee (JPC) was the largest ever exercise carri ed out by a parliamentary panel in India's democratic history. He said over 97.27 lakh petitions, memorandums were received by the JPC through physical and online forma ts and the JPC had gone through each of them before finalising its report. The minis

ter said as many as 284 delegations submitte d their views on the bill besides the Waqf boards of 25 states and Union Territories. Legal luminaries, charitable organisations, academicians and religious leaders, among others, have also submitted their opinions, he said. Union Minister of Minority Affairs Kir en Rijiju speaks in the Lok Sabha during the Budget session of Parliament, in New Delhi, Wednesday, April 2, 2025. "The government is not going to interfere in any religious institution. The changes made in the Waqf law by the UPA government gave it overriding effect over other statutes, hence the new am endments were required," Rijiju said amid no isy opposition protest. "You tried to mislead the people on issues which are not part of the Waqf Bill," Rijiju told the opposition. This

bill has nothing to do with religion, but deals only with properties, he added. According to the bill, trusts created by Muslims under any law will no longer be considered Waqf, ensuring full control over the trusts. As per the bill, only practising Muslims (for at least five years) can dedicate their property to Waqf, restoring pre-2013 rules. Also, women must receive their inheritance before Waqf declaration, with special provisions for widows, divorced women and orphans. The bill also proposes that an officer above the rank of collector will investigate government properties claimed as Waqf. In case of disputes, the senior government official will have the final say on whether a property belongs to Waqf or the government. This replaces the existing system where such decisions are made by Waqf tribunals. Also, the bill proposes that non-Muslim members will be included in the central and state Waqf boards for inclusivity. Women must receive their inheritance before Waqf declaration, with special provisions for widows, divorced women and orphans. Earlier, Speaker Om Birla rejected the opposition's objections that the government has no power to insert new provisions in the amended bill. Unio n Home Minister Amit Shah said the bill was tabled after a long process of consultations carried out by the JPC. Shah said the bill was first introduced in August 2024 after which, as sought by the House, it was referred to the JPC.

CBSE officials to inspect schools in TG

Hyderabad: After the Central Board of Secondary Education (CBSE) decided to act against dummy schools, regional officers from Vijayawada will conduct inspections at schools in Telangana, and submit reports to the CBSE chairman, recommending appropriate actions, including disaffiliation of non-compliant schools. The CBSE has urged parents to verify the affiliation of school before admissions. The board stated that every school must display its affiliation details on its website, including the year of establishment, infrastructure details, and staff information. Parents can check a school's affiliation status using its affiliation number on the CBSE SARAS 6.0 website, which provides information on active affiliations, affiliated schools and change in affiliations and including disaffiliations. Currently, 638 schools in Telangana are affiliated with CBSE, including 128 in Hyderabad. However, experts warn that some institutions misuse CBSE affiliations. "If a management runs

four schools, they may obtain affiliation for only one while falsely claiming that the others as CBSE recognised. These unrecognised institutions often function as tuition centres, which are not regulated by any law," said an education expert. "Many parents, unaware of this malpractice, enroll their children trusting the brand name of the institute," he added. Schools seeking CBSE affiliation will undergo a rigorous approval process that can take one to two years, depending on the compliance with CBSE norms and can face delays if they fail to meet mandatory requirements. "If any deficiencies are found, CBSE notifies the school, allowing them two to three months to rectify the issues," said educationist Vasireddy Amarnath. "If a school fails to meet essential infrastructure standards, its application is rejected outright. Fearing the rejection, school managements continue to wrongly claim CBSE affiliation despite be-



ing not approved, such schools send their students for board exams through other affiliated institutions, these institutions often mislead parents and students by falsely advertising them as CBSE affiliated,"he added. CBSE is working to eliminate such dummy schools, ensuring that students are not misled. "If a school admits students without a valid affiliation number, the responsibility for their future lies entirely with the school," a CBSE official said.

MPSC Delays State Service Exam 2023 Final Results By Over Six Months; Candidates Demand Clarity

Candidates awaiting the final result of the Maharashtra Public Service Commission (MPSC) State Service Examination 2023 have expressed growing frustration over the inordinate delay in the recruitment process. The commission had published the general merit list after interviews in September last year, but despite over six months passing since then, the final result remains undisclosed. The recruitment process, which was initiated almost two years ago for 303 State Service Group-A and Group-B posts, has seen repeated delays at multiple stages. The preliminary examination was conducted on June 4, 2023, with results

declared on September 6. The main examination followed on January 20, 21, and 22, 2024, with results announced on July 16. Candidates then underwent medical examinations between August 1 and September 2, and interviews were conducted from August 13 to September 26. Despite this rigorous schedule, the final result remains pending, further aggravating the uncertainty faced by aspirants. Candidates were given the opportunity to submit their preferences for posts between March 11 and 18, yet, even two weeks after the completion of this process, the final recruitment list has not been released. "When will the final result of the State Service Examination 2023 be declared? Preference link opened two weeks ago, but the result is still awaited!" asked a frustrated candidate.

The World Health Organisation notes that 1 in 100 children globally has autism. In India, it affects about 1-1.5% of 2-9 year olds, with this number set to surge. Involving a diverse range of conditions related to brain development, the traits of autism can be seen in early childhood but are typically not identified until far later. While some autistic children may

lead independent lives, others require life-long care and assistance. Nevertheless, its sway goes beyond one's capacity to intermingle and grasp the world; numerous children with autism also endure mental health concerns, including anxiety, depression and issues with emotional well-being. Nearly 39.6% children detected with autism also qualify for at least one anxiety disorder, making it amongst the most common co-occurring diagnoses. Depression, too, is a main concern for autistic children, especially when they undergo the transition to adolescence. Their issues are intensified by a lack of social engagement, sensory processing combined with the pressure of coping with everyday obstacles. Often, physical symptoms, meltdowns or irritation and repetitive behaviours reflect anxiety and depression. Autistic children also battle emotional control, which prevents them from handling, expressing feelings. Its effects vary greatly, hence, it is crucial to note its manifestations. Autistic individuals frequently experience "Autistic burnout". It occurs when prolonged stress from sensory inputs, emotional demands and social expectations causes deep exhaustion which results in cognitive fatigue and shutdowns and increased sensitivity particularly among individuals who mask their autistic traits. The condition differs from typical burnout because it does not recover through brief periods of rest. Patients need ongoing approaches that include reducing sensory overload, structured rest periods and selfacceptance support. Parents and caregivers should be mindful of the early signs and symptoms exhibited. Screening techniques can help ascertain co-occurring mental health conditions. Likewise, therapeutic techniques such as Cognitive Behavioural Therapy (CBT) have proven to be successful in regulating anxiety. Moreover, treatments containing social narratives and visual aids can be relevant. Also, Applied Behavioural Analysis (ABA) and other strategies meant to teach emotional control and anxiety management are helpful. It encompasses relaxing techniques and positive reinforcements. Children with autism may also gain from other mindfulness-led therapies including guided imagery, progressive muscle relaxation and deep breathing. Severe instances of anxiety and depression might require medication. Parents and caregivers have to let the child be monitored by a medical practitioner during such occurrences. Similarly, they can establish a consistent routine to help emotional control. Furthermore, sensory-friendly environments at home or school might let them calm down. Programs inclusive of training, peer support groups.





Gas fire in Malaysia injures more than 100 people and damages 49 houses

KUALA LUMPUR: A fire caused by a burst gas pipe spread to several homes and sent a fireball soaring into the sky outside Malaysia's largest city Tuesday, injuring more than 100 people. The towering inferno near a gas station in Putra Heights outside Kuala Lumpur was visible for kilometers (miles) and lasted for several hours. It happened during a public holiday as Muslims, who are the majority in Malaysia, celebrate the second day of Eid. National oil company Petronas said the fire started at one of its gas pipelines at 8:10 a.m. and the affected pipeline was later isolated. Disaster management officials said shutting the valves will eventually snuff out the fire. The flames, 20 stories high at one point, were small enough for firefighters to approach around 2:45 p.m., the Selangor state fire department told the Star newspaper. At least 49 houses were damaged and 112 people were injured, with 63 sent to the hospital for burns, breathing difficulties and other injuries, Selangor Deputy Police Chief Mohamad Zaini Abu Hassan was quoted by national Bernama news agency as saying. Selangor Chief Minister Amirudin Shari said the fire department evacuated nearby homes as a safety measure and the residents will be placed in mosques nearby until the situation is under control. Pictures and videos of the fireball went

viral on social media, with some residents saying they felt a strong tremor with the doors and windows of their homes shaking. Lee Weng Ken, who suffered burns to his left leg, said he was shocked when the cailing of his house collapsed and crushed his vehicle parked in the

NEW YORK: India is amazing from space, NASA astronaut Sunita Williams said and voiced optimism that she will visit her father's home country and share experiences about space exploration with people there. Sunita made these remarks during a press conference Monday.

She was responding to a question on how India looked from space when she was in the International Space Station and on possibility of her collaborating with Indian Space Research Organisation (ISRO) on space exploration. "India is amazing. Every time we went over the Himalayas, and I'll tell you, Butch got some incredible pictures of the Himalayas. Just amazing," Sunita said. The 59-year-old NASA astronaut and fellow astronaut Butch Wilmore addressed reporters at their first joint press conference days after they returned to Earth as part of the SpaceX Crew-9 mission, having been stranded in space for over nine months. "And you can see, like I've described it before, just like this ripple that happened, obviously when the plates collided, and then as it flows down into India. It's many, many colours," she said. "I think, when you come from the east, going into like Gujarat and Mumbai, the fishing fleet that's off the coast there gives you a little bit of a beacon that here we come, and then all throughout India, I think the impression I had was it was just like this network of lights from the bigger cit-

Nonprofit groups and Democrats sue Trump administration over election executive order

NEW YORK: President Donald Trump's executive order seeking to overhaul the nation's elections faced its first legal challenges Monday as the Democratic National Committee and a pair of nonprofits filed two separate lawsuits calling it unconstitutional. The Campaign Legal Center and the State Democracy Defenders Fund brought the first lawsuit Monday afternoon. The DNC, the Democratic Governors Association, and Senate and House Democratic leaders followed soon after with a complaint of their own. Both lawsuits filed in the U.S. District Court for the District of Columbia ask the court to block Trump's order and declare it illegal. "The president's executive order is an unlawful action that threatens to uproot our tried-andtested election systems and silence potentially millions of Americans,"



said Danielle Lang, senior director of voting rights at the D.C.-based Campaign Legal Center. "It is simply not within the president's authority to set election rules by executive decree, especially when they would restrict access to voting in this way." The legal challenges had been expected after election lawyers warned some of Trump's demands in the order, including a proof-of-citizenship requirement for voter registration and new ballot deadline rules, may violate the U.S. Constitution. The order also asserts power that legal experts say the president doesn't have over an independent agency. That agency, the U.S. Election Assistance Commission, sets

voluntary voting system guidelines and maintains the federal voter registration form. The suits come as Congress is considering codifying a proofof-citizenship requirement for voter registration into law, and as Trump has promised more actions related to elections in the coming weeks. Both the legal challenges draw attention to the Constitution's "Elections Clause," which says states - not the president — get to decide the "times, places and manner" of how elections are run. That section of the Constitution also gives Congress the power to "make or alter" election regulations, at least for federal office, but it doesn't mention any presidential authority over election administration.

Iran readies missiles for potential response

Tehran: Hours after US President Donald Trump on Sunday threatened Iran with bombing and secondary tariffs, the armed forces in Iran have reportedly readied missiles for a potential response. According to a report with the Tehran Times, a significant number of launch-ready missiles have been located in underground facilities scattered across the country, designed to withstand airstrikes. Trump had threatened Iran with bombings and secondary tariffs if Tehran did not come to an agreement with Washington over its nuclear program. In his first remarks since Iran rejected direct negotiations with Washington last week, he told NBC News that the US and Iranian officials were talking, but did not elaborate. Local event listings "If they don't make a deal, there will be bombing," Trump said in a telephone interview. "It will be bombing the likes of which they have never seen before." There's a chance that if they don't make a deal, that I will do secondary tariffs on them like I did four years ago," he added. In response, Iran sent a letter to Trump through Oman, urging Tehran to reach a new nuclear deal, saying its policy was to not engage in direct negotiations with the United States while under its maximum pressure campaign and military threats, Tehran's foreign minister was quoted as saying on Thursday.

China's provocations threaten regional peace, says Taiwan after Beijing's military drills



Taipei: Strongly condemning China's joint military drill around Taiwan, Taipei on Tuesday said that Beijing's provocations are threatening regional peace. This comes after 19 Chinese Navy ships operating around Taiwan were detected on Tuesday morning. The Taiwanese Ministry of National Defence condemned the move, which it called a disruption to the status quo, and said it had deployed military vessels and aircraft in response to the threats.19 Chinese Navy ships operating around Taiwan were detected on Tuesday morning. Taiwan's Armed Forces have monitored the situation and employed CAP aircraft, Navy ships, and coastal missile systems in response to detected activities," the defence ministry stated. The Taiwanese Ministry of Foreign Affairs demanded China stop destabilising the status quo and Indo-Pacific peace and stability through "reckless behaviour. We strongly condemn China's joint military drills near Taiwan. CCP's provocations from the East & South China Seas to Oceania threaten regional peace. We urge Beijing to stop destabilising the status quo & Indo-Pacific peace & stability through reckless behaviour." Meanwhile, the defence ministry said that Taiwan adheres to the principle of "no escalation of conflict, no provocation of disputes, responding prudently to grey-zone harassment to safeguard national sovereignty and the security of the people." The drills took place after US Secretary of Defense Pete Hegseth left Taiwan following visits to Japan and the Philippines. During his visit, he criticised China and said Japan was "indispensable" for tackling Chinese aggression. "Taiwan is their best excuse. That's why they chose to launch such military drills as soon as the US defence secretary left Asia," Taiwan's leading newspaper, Taipei Times, reported, quoting an official. The defence ministry, earlier on Tuesday, said that the PLA Navy vessels, led by the aircraft carrier, Shandong, were detected from March 29 and entered into Taiwan's response zone. It said that Taiwanese forces have monitored the situation and responded accordingly."

NRI remittances soar to record \$129.4 billion in 2024, India retains top rank

New Delhi : Indians working abroad for Economic Co-operation and Develsent home a record \$129.4 billion in 2024 with the highest-ever inflows of \$36 billion in the October-December quarter, according to the latest figures compiled by the Reserve Bank of India (RBI). India tops the list of recipient countries for remittances in 2024 and is way ahead of second-placed Mexico with \$68 billion. China (\$48 billion) is at the third spot followed by the Philippines (\$40 billion), and Pakistan (\$33 billion), according to figures compiled by World Bank economists. The growth rate of remittances in 2024 is estimated to be 5.8 per cent, compa red to 1.2 per cent registered in 2023, according to World Bank data. The number of Indians working overseas has tripled from 6.6 million in 1990 to 18.5 million in 2024, with its share in global migrants rising from 4.3 per cent to over 6 per cent during the same period.Indian migrants in the Gulf countries account for around half of the total Indian migrants in the world. The recovery of the job markets in the highincome countries of the Organisation

opment (OECD), following the onset of the COVID-19 pandemic, has been the key driver of remittances. This is especially true for the United States where the employment of foreign-born workers has recovered steadily and is 11 per cent higher than the pre-pandemic level seen in February 2020. Officially recorded remitt ances to lowand middle-income countries (LMICs) are expected to reach \$685 billion in 2024. According to the World Bank, remittances have continued to outpace other types of external financial flows, such as FDI, to low and middle-income countries and will continue to increase because of enormous migration pressures driven by demographic trends, income gaps, and climate change. During the past decade, remittances increased by 57 per cent, while FDI declined by 41 per cent. Remittances will likely continue to increase because of enormous mig ration pressures driven by demograp hic trends, income gaps, and climate change, the World Bank report explained.

GST Collection Grows 9.9% To Over Rs 1.96 Lakh Crore In March

New Delhi: Gross GST collection grew 9.9 per cent in March to over Rs 1.96 lakh crore - the second-highest mop-up ever, government data showed on Tuesday. GST revenue from domestic transactions rose 8.8 per cent to Rs 1.49 lakh crore, while revenue from imported goods was higher 13.56 per cent to Rs 46,919 crore. The gross collection includes Central GST mop-up of Rs 38,145 crore, State GST collection of Rs 49,891 crore and Integrated GST (IGST) of Rs 95,853 crore. Cess collection during March stood at Rs 12,253 crore. Total refunds during March rose 41 per cent to Rs 19,615 crore. After adjusting refunds, net GST revenue stood at over Rs 1.76 lakh crore in March 2025, a 7.3 per cent growth over the yearago period. GST collection had hit a record high of Rs 2.10 lakh crore in April 2024. Deloitte India Partner MS Mani said the 9.9 per cent increase in gross GST collection for the month reflects the impact of year-end sales push by businesses. "It is very encouraging to see that this is not an isolated instance as GST collections have shown a steady increase every month reflected by the 9.4 per cent increase in annual Gross GST collections," Mani said. Gross GST collection during April-March stood at Rs 22.08 lakh crore, a 9.4 per cent Y-o-Y growth. "There continues to be a wide variation in the growth rates of GST collections across key manufacturing and consuming states . While states like Maharashtra, Haryana, UP, Rajasthan have shown a growth exceeding 10 per cent, other states



like Gujarat, Karnataka, Telengana, AP, Tamil Nadu have been in the range of -1 per cent to 7 per cent, which is very unusual for the month of March. There is a need to understand the reasons for the same by evaluating the sectoral growth and compliance rates in these states," Mani said. KPMG in India, Partner and Head, Indirect Tax, Abhishek Jain said, a nearly 10 per cent growth in collections compared to last year reflects economic stability and strong tax compliance by companies. "With fiscal year-end adjustments and reconciliations underway, we can expect a further surge in month-on-month growth in the next set of collection," Jain added.

Among the top performers, Maruti Suzuki, Mahindra & Mahindra, and Kia India showcased impressive growth in their SUV sales. Maruti Suzuki India, the largest car manufacturer in India, saw a growth of nearly 4.5 per cent in its SUV sales in March 2025, with 61,097 units sold compared to 58,436 units during the same month last year. The overall sales of Maruti Suzuki in March 2025 rose by 3.1 per cent yearon-year (YoY), totalling 192,984 units, up from 1,87,196 units in March 2024. The company also posted its highest-ever annual



sales of 22,34,266 units for FY25, which includes its highest-ever domestic sales of 17,95,259 units and exports of 3,32,585 units. Mahindra & Mahindra also made significant strides in the SUV market, selling 48,048 vehicles in the domestic market in March -- which is an 18 per cent growth. Overall, the company's SUV sales, including exports, stood at 50,835 vehicles for the month. UPI Payments Hit New High With Rs 24.77 Lakh Crore Transactions In March

New Delhi: The Unified Payments Interface (UPI) saw a 13.59 per cent increase (on-month) in transaction volume at 18.3 billion in the month of March, from 16.11 billion in February, the National Payments Corporation of India (NPCI) data showed on Tuesday. The month of March saw a record Rs 24.77 lakh crore worth UPI-based transactions, up 12.79 per cent from Rs 21.96 lakh crore in February. On a daily basis, the UPI network recorded more than 590 million average transactions at Rs 79,910 crore daily transaction count, according to the NPCI data. On a year-on-year basis, the recordbreaking UPI transactions of Rs 24.77 lakh crore in March marked a 25 per cent surge in value and an impressive 36 per cent growth in volume, demonstrating the unstoppable momentum of India's digital payments revolution. With daily transactions averaging Rs 79,910 crore, up 1.9 per cent from February, and volumes rising 2.6 per cent, these numbers underscore the rapid adoption and trust in digital financial solutions. Meanwhile, as digital payment users on Tuesday faced issues in processing transactions on UPI, the NPCI attributed the reason to the closing of the financial year 2024-25 (FY25). "Today, due to the financial year closing, some of the banks are facing intermittent transaction declines. UPI system is working fine, and we are working with the concerned banks for necessary redressal," the NPCI said in a statement. From April 1, it will be mandatory for UPI member banks, UPI apps, and third-party providers to follow these new guidelines. According to the new norms, the UPI ID linked to the inactive mobile number will become inactive. That is, if the mobile number registered with the bank of a UPI user is inactive for a long time, then the UPI ID of the user will also be unlinked, and the person will not be able to use the UPI service. In such a situation, every person using the UPI service will need to ensure that the mobile number registered with his bank is active.

Anupama clarifies, "The first mistake people make is to believe that millet will work for everyone across the board. This is not true. Not true in fact of any food. If you are trying millets for the first time, watch and check for how you feel when it is regularly included in your diet - then if it works with your gut, please go ahead and include it in variety in your diet, if it does not minimize its use if you have to use it at all. It uses a lot of water in cooking, hence works best if cooked like a kichadi or even a roti."

Do's and don'ts of eating millets

You can consume millet at any time of the day, preferably in the morning, at noon and at night. It is best to consume millet in moderate amounts; three or four times a week is ideal. However, it is not recommended for people with hypothyroidism. Anupama shares, "People having thyroid disorders should avoid consuming millet because it leads to the enlargement of the thyroid. Too much millet could (could) interfere with the functioning of the thyroid gland.' Deepali explains, "The ideal millets to be eaten in the summer are Jowar, Ragi, Foxtail millet, Barnyard millet and Kodo millet. These cooling millets can be incorporated into your diet in summers. In India, about 8 millet types are cultivated under rain-fed conditions which require little or no irrigation, as they do not require high amounts of moisture.

For example, Jowar is a rain-fed crop (30-100cm, annually) grown in the areas which barely need irrigation. Ragi, Foxtail Millet, Bajra and Barnyard Millet are heating millets which means they should ideally be consumed during the winter season. On the other hand, Little Millet and and can be eaten during the sum-



Bailey Ashwani first stole the show with a sensational 4-24, the best figures by an Indian bowler on his IPL debut, as KKR were bowled out for 116 in 16.2 overs. Later, Rickelton's unbeaten 62 off 41 balls ensured MI chased down 117 with ease in just 12.5 overs. "It was a complete performance. Winning the toss, bowling first, and executing their plans beautifully. Bringing in an extra seamer, Ashwani, who was outstanding. They took wickets consistently, and I think that was the most pleasing aspect. It's not often nowadays, with the impact player rule, that you see a team preventing any substantial partnerships. But they applied tells the whole story," he added.

Delhi Police has arrested film director Sanoj Kumar Mishra following allegations of rape and coercion. The case involves a 28-year-old woman who claims she met Mishra in 2020 through social media platforms TikTok and Instagram. According to the complaint, Mishra allegedly manipulated her into meeting him by threatening suicide. On June 18, 2021, he reportedly took her to a resort, drugged her, and sexually assaulted her. The victim stated that Mishra captured compromising photos and videos, using them to blackmail her into a relationship. Promising marriage and film opportunities, he allegedly forced her into a live-in arrangement in Mumbai, where he reportedly assaulted her multiple times. She further claimed that she was coerced into three abortions. In February 2025, Mishra allegedly abandoned her and threatened to leak her private content if she reported him. Following her complaint, an FIR was registered under multiple charges, including rape, assault, and criminal intimidation. Medical records from Muzaffarnagar confirmed the forced abortions.
